Please take a moment to read the Admission Policy below.

Completing any Global SOF Foundation (GSOF) event registration constitutes your signature and consent to the Admission Policy as stated below.

General

Global SOF events are open to professional representatives from the defense and security sector, including but not limited to, U.S. and partner nation military, U.S. and partner nation government civilian personnel, non-profit organizations, relevant industry partners, think tanks, academia, and media.

Admission is restricted to relevant professional and government visitors. Visitors should be involved in, or have some legitimate connection to, special operations forces and associated industries. All exhibitor personnel, visitors, academics, guests, contractors, and service providers are subject to a multi-layered security verification process, which includes, but is not limited to, identity validation, sanctions and watch-list screening, and affiliation verification to confirm eligibility.

Anyone wishing to attend any portion of an event must pre-register via the event website. Registration should be completed as early as possible to ensure sufficient time to process it before the event.

GSOF organizers reserve the right to deny access to, or remove from the event, any individual who is found to be violating this policy or reasonably deemed to pose a security risk or a likelihood of non-compliance.

Standard Dress Code

Military: Uniform of the Day / Duty Uniform

Civilian: Business Casual

Specific event dress codes may vary; consult the event's FAQ page for more information.

Age Restrictions

No person under 18 years of age, including dependents of speakers or exhibitors, will be admitted to any GSOF event unless the organizers have granted written permission. In the event of an exception, minors will always require an escort within event spaces.

Alcoholic beverages may be served at events. Drinks will only be served to individuals who can provide proof of age. It is strictly prohibited for anyone under the age of 21 to possess, consume, or be supplied with alcohol at the event. Violations can lead to consequences such as being asked to leave the event, having one's access revoked, or facing legal repercussions.

Codes of Conduct

- As an attendee, you agree to abide by the [GSOF Event Code of Conduct](#).
- As an attendee, you are expected to follow the rules and regulations set by the event venue. This includes respecting venue policies, such as not bringing outside food or beverages if they are prohibited. It's always a good practice to familiarize yourself with a venue's guidelines to avoid inconvenience.

Cancellation and Substitution

Cancellation requests must be submitted in writing; telephone cancellations will not be accepted. Please email your cancellation request to info@gsof.org.

- **Up to three weeks prior to an event start date:** Refunds will be issued minus a \$75 administrative fee.
- **Three weeks or less before the event start date, including no-shows:** No refunds will be provided.

Prohibited Weapons/Items at All GSOF Events

The following restricted weapons/items and guidelines are in effect for all GSOF events and their corresponding venues.

- Firearms (including concealed carry), explosives, knives, stun guns, handcuffs, brass knuckles, sticks, batons, martial arts instruments, pepper spray, tear gas and knives, fireworks, smoke canisters, aerosols, air horns, noisemakers, flares, dangerous or hazardous items, illegal substances, laser devices, bottles, glass vessels, cans, poles, or any article that may compromise public safety or which may pose a hazard or nuisance to any other person, are strictly prohibited. The possession or attempted introduction of any prohibited item will result in confiscation, removal from the premises, and possible referral to authorities.

- Weapons storage is not available for personal firearms. The weapons storage options for each specific event will be provided to exhibitors upon completion of the exhibition contract.
- Guests may be subject to a search upon entry. Anyone possessing prohibited items will be asked to remove the item from the venues or dispose of it. GSOF Security reserves the right to deny entry to individuals who refuse to comply with screening or are suspected of concealing prohibited items.
- **Off-duty law enforcement, private security contractors, or foreign protection agents are strictly prohibited from carrying weapons on site, regardless of credentials, unless explicitly approved by GSOF Security for protective detail purposes.**
- Signal jammers, RF interference devices, or mobile surveillance technology (e.g., IMSI catchers, packet sniffers) are strictly forbidden and subject to federal reporting.

Geofencing and Unauthorized Data Collection

Geofencing and unauthorized data collection are strictly prohibited. Any individual or organization found participating in geofencing or unauthorized data collection will be immediately ejected from the event and barred from participating in any GSOF events.

No Unauthorized Aircraft or Drone Activity

Flying or operating any unauthorized manned or unmanned aircraft, including drones, is strictly prohibited inside the venue, in outdoor event spaces, and within the surrounding area. Such activity poses significant safety and security risks, causes unnecessary alarm to attendees, and will result in immediate intervention by security personnel and potential legal action in accordance with applicable laws and regulations.

Admission and Identification

Identification Badge: All exhibitor personnel, visitors, guests, contractors, and service providers acknowledge that the official event identification badge is their admission ticket to all GSOF event activities.

Attendees must display name badges at all times during the event. No registered person may permit another person to wear their given badge. No badge should be defaced, altered, transferred, or reproduced. Any discovery of counterfeit badges will result in immediate removal and referral to law enforcement.

GSOF security personnel reserve the right to conduct random badge audits and identity verification checks at any time during the event. Attendees are required to comply promptly with such requests. All individuals participating in GSOF functions must carry a valid photo ID and be prepared to present an official form of photographic identification, such as a passport, driver's license, or national ID, upon request.

- Your **identity documents** will be used for security vetting and identity verification purposes.
 - Data is collected in the form of image data for ID purposes. This data is stored in the database as a binary large object (BLOB) and is subject to database encryption and security measures.
 - By collecting and uploading individual personal ID documentation, you have obtained the appropriate consent from your employer.
 - Digital copies of event badges, QR codes, or mobile credentials may not be shared or displayed on unauthorized platforms (e.g., social media). Unauthorized duplication or transmission is strictly prohibited.
- Your **verification photo** will be used for security vetting and access control purposes, but will also be associated with your profile in the Global SOF Mobile App. Your photo and profile will only be visible in the App once you give explicit consent, which will be requested upon your initial login to the App. You will also have the option to change your photo upon login to the App, if desired.

- Any person found to be registering to attend a GSOF event using false information or credentials or deliberately withholding information will have their application automatically denied and may be subject to prosecution.
- The organizers reserve the right to exclude any person(s) without prejudice.

Multimedia

Photography / Filming

- Photography of booths and/or exhibits is only allowed with the expressed permission of the booth manager.
- Closed-Circuit Television Cameras (CCTV) and Advanced Identity Verification Systems will operate at all times during GSOF events. The organizers reserve the right to deliver the archived video media to the Police or other competent authorities as evidence if requested. The contents of such media may be used as evidence in a court of law.
- GSOF will have photographers and videographers at this event, both internal to the Staff and approved third parties. As an attendee, you hereby consent to and authorize the use and reproduction by GSOF of any and all photography and/or videography taken on this day for any purpose without compensation. All digital images and/or video files are wholly owned by GSOF, which reserves the right to use these images and/or videos for publication on our digital and print platforms.
- Attendees may not take pictures in the exhibit hall. Exceptions are made only when permission is obtained from the exhibitors whose booth/product is being photographed/ videotaped, and all individuals appearing in the photo/video. Attendees' commercial use of photographs is prohibited.

Multimedia Products

No sponsorship, promotional, marketing, political, or prohibited materials may be brought into, used, or displayed by any person inside a GSOF event without the expressed written permission of the organizers. Any person possessing non-permitted items may be refused entry to or ejected from the venue and site. Prohibited items include, but are not limited to:

- Products that include hate speech toward any race, culture, ethnic group, or religion

- Material endorsing or disparaging a political figure, U.S. government official, or foreign nation
- Material with lewd or nefarious content
- Products with language that implies endorsement by the event organizer

Security

Badge Scanning and Data Collection

- As an attendee, you acknowledge that your badge will contain a QR code. Event staff may scan your badge at the entrance to the event. This is purely to identify your badge type and event access eligibility; no data is transferred as a result of badge scanning.
- All attendees must strictly adhere to the access limitations defined by their badge type. Attempting to enter restricted exhibition or conference areas without proper authorization is a violation of GSOF security policy and may result in removal from the event and revocation of credentials.
- The QR code on your badge may also be scanned using a "lead retrieval" device. As an attendee, you agree that by allowing your badge to be scanned by an exhibitor at the event, you consent to the following information being shared with the scanning organization:
 - Rank / Prefix
 - First and Last Name
 - Title
 - Company / Organization
 - Registration Type
 - Email Address
 - Work Location (City, State, Zip Code, Country)

This is similar to providing them with your business card. Any attendee may decline that their badge be scanned for lead retrieval purposes.

Export Control

- Visitors should be aware that export control regulations may apply to exhibits based upon both U.S. legislation and legislation from the territory of origin of the exhibitor. Such legislation or regulations may cover the exportation of goods, the transfer of technology, the provision of technical assistance overseas, and activities connected with trade in controlled goods. Exhibitors whose activities may be impacted by such legislation or regulations must ensure they have the necessary licenses and mechanisms in place.
- Any visitor who, at the sole discretion of the organizer, is deemed to be engaging in controlled business or activity during the exhibition and who does not have relevant trade control licenses may be subject to action on the part of the organizers, including revocation of the application to attend and expulsion from the event. The relevant authorities will be informed of any such activity, which may result in legal action being taken against the visitor by these authorities. Visitors expelled from the event will have no claim for redress against the organizers nor any refund for loss of fees.

Liability

By attending this event, you accept that GSOF is not responsible for any accidents, illnesses, or injuries incurred. While GSOF provides a professionally managed security environment, attendees acknowledge that participation in defense-sector events may inherently include exposure to physical or cyber threats. GSOF is not liable for incidents caused by the acts of third parties or nation-state threat actors.

Participation Eligibility and Sanctions Compliance

GSOF events are subject to all applicable U.S. Department of State sanctions, restrictions, and guidance. Participation may be limited or denied to individuals or organizations originating from or affiliated with countries, entities, or persons subject to U.S. sanctions or other governmental limitations. GSOF reserves the authority to interpret and apply these restrictions at its discretion to maintain compliance, uphold event security standards, and preserve the integrity of international and domestic engagements.
